Points Declaration Form

THIS APPLICATION FOR POINTS MUST BE FILLED OUT AND SUBMITTED WITH THE POINTS FILING FEE BEFORE POINTS WILL BE ACCUMULATED FOR YEAR END AWARDS. MEMBERS MUST SUBMIT FORM AND FEE BEFORE A SHOW FOR WHICH THEY WISH TO KEEP POINTS FROM.

A FILING FEE OF \$5.00 PER HORSE AND/OR EXHIBITOR MUST BE PAID IN ORDER TO KEEP POINTS IN CALIZONA ApHC IN 2012. IF POINTS ARE TO BE KEPT ON THE EXHIBITOR A \$5.00 FEE MUST BE PAID FOR THAT INDIVIDUAL. IF POINTS ARE TO BE KEPT ON THE HORSE A \$5.00 FEE MUST BE PAID FOR THAT HORSE. IF A PERSON PLANS TO KEEP POINTS IN BOTH PLEASURE AND EQUITATION A TOTAL OF \$10.00 MUST BE PAID BECAUSE POINTS ARE KEPT ON THE HORSE IN PLEASURE AND ON THE EXHIBITOR IN EQUITATION.

HORSE(S) MUST BE OWNED OR LEASED BY A CALIZONA MEMBER, WITH THE EXCEPTION OF NON-PRO AND YOUTH EXHIBITORS WHO MUST OWN THE HORSE PER ApHC RULES. A COPY OF THE HORSES PAPERS AND LEASE (if applicable) MUST BE SUBMITTED TO THE POINTS CHAIRPERSON. IT IS THE RESPONSIBILITY OF THE MEMBER TO READ AND UNDERSTAND THE RULES. THIS CIRCUIT IS ALSO OPEN TO ALL BREEDS.

YOUTH EXHIBITORS ARE REQUIRED TO PUT THEIR AGE ON ALL SHOW APPLICATIONS AND SHOULD BE PREPARED TO SHOW PROOF OF AGE SHOULD ANY QUESTION ARISE.
